7 Every purchaser of any interest in residential real property on which a residential dwelling was built prior to 1978 is  
8 notified that such property may present exposure to lead from lead-based paint that may place young children at risk of  
9 developing lead poisoning. Lead poisoning in young children may produce permanent neurological damage, including  
10 learning disabilities, reduced intelligence quotient, behavioral problems, and impaired memory. Lead poisoning also poses  
11 a particular risk to pregnant women. The seller of interest in residential real property is required to provide the buyer with  
12 any information on lead-based paint hazards from risk assessments or inspections in the sellers possession and notify the  
13 buyer of any known lead-based paint hazards. A risk assessment or inspection for possible lead-based paint hazards is  
14 recommended prior to purchase.

28 pamphlet, *Protect Your Family From Lead in Your Home*; disclose to Buyer the presence of any known lead-based paint or  
29 lead-based paint hazards in the housing being sold; disclose to the real estate licensee the presence of any known lead-based  
30 paint or lead-based paint hazards in the target housing and the existence of any available records or reports pertaining to the  
31 same; and provide those records or reports to the Buyer. Seller is aware that civil and criminal penalties may be imposed if the  
32 Seller fails to comply with these obligations. Seller must retain a copy of this disclosure for at least three years after the  
33 completion date of the sale.

34 **Ten-day Opportunity to Conduct a Risk Assessment or Inspection. (Seller/Buyer initial)**

35 (d) Seller hereby advises the Buyer that the Buyer has the right to a 10-day opportunity to conduct a risk assessment or  
36 inspection for the presence of lead-based paint and/or lead-based paint hazards before becoming obligated under the contract to  
37 purchase the housing. The parties may agree to a different period of time or the Buyer may waive the risk assessment or  
38 inspection opportunity in writing. The Buyer's decision regarding the 10-day opportunity should be reflected in the Buyers  
39 offer. See e.g., Contract to Buy and Sell Real Estate, WAR Form 300, Section XI, Inspections.
